## Mobile Phones – Student Use Policy 2023



### Help for non-English speakers

### PURPOSE

To explain to our school community the Department's and Red Hill Consolidated School's policy requirements and expectations relating to students using mobile phones and other personal mobile devices, such as smartwatches and iPads during school hours.

### SCOPE

This policy applies to:

1. All students at Red Hill Consolidated School and
2. Students' personal mobile phones and other personal mobile devices brought onto school premises during school hours, including recess and lunchtime.

### DEFINITIONS

**A mobile phone** is a telephone with access to a cellular (telecommunication) system, with or without a physical connection to a network. "For the purpose of this policy, "mobile phone" refers to mobile phones and any device that may connect to or have a similar functionality to a mobile phone such as smart watches."

### POLICY

Red Hill Consolidated School understands that students may bring a personal mobile phone to school, particularly if they are travelling independently to and from school.

At Red Hill Consolidated School:

- Students who choose to bring mobile phones or any other smart device to school must have them switched off and securely stored during school hours
- Exceptions to this policy may be applied if certain conditions are met (see below for further information)
- When emergencies occur, parents or carers should reach their child by calling the school's office.

### Personal mobile phone use

In accordance with the Department's [Mobile Phones – Student Use Policy](#) issued by the Minister for Education, personal mobile phones must not be used at Red Hill Consolidated School during school hours, including lunchtime and recess, unless an exception has been granted.

Where a student has been granted an exception, the student must use their mobile phone for the purpose for which the exception was granted, and in a safe, ethical and responsible manner.

## Secure storage

Mobile phones and other smart devices owned by students at Red Hill Consolidated school are considered valuable items and are brought to school at the owner's (student's or parent/carer's) risk. Students are encouraged not to bring a mobile phone or smart devices to school unless there is a compelling reason to do so. Please note that Red Hill Consolidated School does not have accident insurance for accidental property damage or theft. Students and their parents/carers are encouraged to obtain appropriate insurance for valuable items. Refer to the Red Hill Consolidated School's Personal Property Policy AND/OR the Department's [Claims for Property Damage and Medical Expenses policy.](#)

Where students bring a mobile phone or smart device to school, Red Hill Consolidated school will provide secure storage. Secure storage is storage that cannot be readily accessed by those without permission to do so. At Red Hill Consolidated school students are required to store their phones and smart devices into the classroom's locked storage arrangement.

## Enforcement

Students who use their personal mobile phones or smart device inappropriately at Red Hill Consolidated school may be issued with consequences consistent with our school's existing student *Student Wellbeing and Engagement* and/or *Code of Conduct* policies.

At Red Hill Consolidated School inappropriate use of mobile phones and smart devices is **any use during school hours**, unless an exception has been granted. In particular, this policy aims to avoid any of the following uses with a mobile phone:

- in any way that disrupts the learning of others
- to send inappropriate, harassing or threatening messages or phone calls
- to engage in inappropriate social media use including cyber bullying
- to capture video or images of people, including students, teachers and members of the school community without their permission
- to capture video or images in the school toilets, changing rooms, swimming pools and gyms
- during exams and assessments

## Exceptions

Exceptions to the policy:

- may be applied during school hours if certain conditions are met, specifically,
  - Health and wellbeing-related exceptions; and
  - Exceptions related to managing risk when students are offsite.
- can be granted by the Principal, or by the teacher for that class, in accordance with the Department's [Mobile Phones — Student Use Policy](#).

The three categories of exceptions allowed under the Department's [Mobile Phones — Student Use Policy](#) are:

### 1. Learning-related exceptions

## ***3. Exceptions related to managing risk when students are offsite***

Where an exception is granted, the student can only use the mobile phone for the purpose for which it was granted.

## **Camps, excursions and extracurricular activities**

Red Hill Consolidated School will provide students and their parents and carers with information about items that can or cannot be brought to camps, excursions, special activities and events, including personal mobile phones.

### **Exclusions**

This policy does not apply to

- Out-of-School-Hours Care (OSHC)
- Out-of-school-hours events
- Travelling to and from school (except on a school bus service)
- Students undertaking workplace learning activities, e.g. work experience

## **COMMUNICATION**

This policy will be communicated to our school community in the following ways:

- Available publicly on our school's website (or insert other online parent/carer/student communication method)
- Included in staff induction processes and staff training
- Included in school newsletter

- Included in staff handbook/manual
- Discussed at annual staff briefings/meetings
- Included in transition and enrolment packs
- Discussed at parent information nights/sessions
- Hard copy available from school administration upon request
