Dear Families and Friends,

Welcome to the 2020 School Year. I hope that you all managed some time off and enjoyed the summer break with your wonderful children.

I would like to extend a very warm welcome to Red Hill Consolidated School to all of our new families. We are all very excited about this year and I'm looking forward to talking to the students about their holidays. I also can't wait until Monday to meet our new little VIPs (Very Important Preps).

Firstly, I would like to welcome and introduce a number of new faces to the Red Hill Consolidated School Team. Darcie Carter in Grade 2C, Jacob Mehrtens in 4M and Kathy McLaren in 5M, as well as David Muzyk who will be overseeing Wellbeing who have all joined our teaching staff in 2020.









We also have three familiar faces returning to Red Hill. Stacey Dempster, Lauren Smart and Rhiannon Petris have all returned from Family Leave this year. And finally, Belinda Rankin and Elise Pentland have joined our amazing Education Support Staff Team, and will be working primarily in our Prep classrooms. If you see these new staff members in the playground please say hello.

Building & Ground Works

A number of substantial projects took place over the holidays. All remaining category 3 asbestos was removed from our buildings and some renovations took place in the Palace, including re-carpeting and removal of some internal walls. We are also awaiting brand new display boards in these classrooms. Our Lower Sandy car park and gymnasium access road was resurfaced last week. I would like to sincerely thank Hillview Quarries for the generous donation of crushed rock for this project. I would also like to acknowledge Andrew Sides for his work over the break. Andrew co-ordinated the car park project and also slashed our school nature strips.

Tree removal and pruning works will begin at Red Hill Consolidated School this week. All diseased and dangerous trees and limbs are scheduled for removal at no cost to the school. This is unfortunate timing, but every measure is being

taken to ensure children are safe and learning is not interrupted. Works will be put on hold during recess and lunch breaks as well as drop off and pick up times. Some works will be carried out on weekends, so please be aware if you are visiting our grounds outside of school hours.

Bushfires

The terrible news of the devastating bushfires over the holidays has shocked us all. If you and your family were affected by these fires, please get in contact with the school. The Department of Education and Training have a number of services and supports to assist impacted families. It is also important for our teachers to be aware in order to support your child. Some children may begin to develop some worries around bushfires. With this in mind, we will be very sensitive when conducting our mandatory evacuation drills and discussing the threat of bushfire at Red Hill.

With that in mind, Red Hill Consolidated School is a Code Red School, identified as being at a higher risk of bushfire. As a Code Red School, we are required to take a number of precautions, undertake training and drills, as well as close the school on Code Red days. An information sheet regarding Code Red days has been included in this newsletter.

Please also ensure we have up to date information regarding any medical conditions your child may suffer from. The smoke haze from bushfires as well as thunderstorms typical at this time of the year can be a trigger for asthma. If this is the case for your child, please let us know.

Student Information Update Pack

A student Information Update pack along with consent forms is being sent home this week. A number of forms will need to be completed and returned. This pack contains:

- Student Information to be updated, and signed
- Release of Contact Details for Class Contact Representatives
- Consent Publish to Media (for the duration of time at Red Hill Consolidated School)
- Consent Head Lice Inspections (for the duration of time at Red Hill Consolidated School)
- Digital Technologies Use Agreement (this is required to be completed each year)

Also being sent home is the Camps, Sports and Excursions Funds form (CSEF). We ask eligible families to return this as soon as possible. To make things a little easier at this end, we do ask you to return all forms at the same time, no later than Friday 7th of February.

Hats

It is shaping up to be a hot Term 1. As always, students must have a broad brimmed hat when outdoors in Term 1 and 4. With very hot weather forecasted this week, children must have a hat from day one. We also encourage children to apply sun screen before school and to have a water bottle on their desk at all times.

Mobile Phone Policy

While we're on the topic of policies, please ensure you and your children are aware of the state-wide policy for mobile phones at school. If your child must have a mobile phone at school, it will need to be switched off and stored securely during school hours. Our classes from 4 to 6 have been provided with lockable storage for mobile phones. If you have a child in a younger year level who requires a mobile phone at school, please contact the

office and we will arrange secure storage for your child's device. We ask that all children sign their devices in and out and for any bus travellers to keep mobile phones in their school bags whilst travelling on the bus. Our school's mobile phone policy can also be found on our website.

Student Banking

Student banking will no longer be available at Red Hill Consolidated School in 2020. This is due to an enormous decrease in deposits, which is most likely due to the use of electronic banking..

Assemblies

We will be trialling Friday afternoons from 2:30pm for assemblies this year. This may suit some families, but the decision to trial this new time was to increase prime learning time for our students. The other big change this year is in our canteen. Our canteen is now being run by Stir Crazy Kids five days a week. 


Future Newsletters

Camps, Sport and Excursions Fund Application

School camps provide children with inspiring experiences in the great outdoors, excursions encourage a deeper understanding of how the world works and sports teach teamwork, discipline and leadership. All are part of a healthy curriculum.

CSEF is provided by the Victorian Government to assist eligible families to cover the costs of school trips, camps and sporting activities.

If you hold a valid means-tested concession card or are a temporary foster parent, you may be eligible for CSEF. A special consideration category also exists for asylum seeker and refugee families. The allowance is paid to the school to use towards expenses relating to camps, excursions or sporting activities for the benefit of your child.

The annual CSEF amount per student is:

- \$125 for primary school students
- \$225 for secondary school students

CSEF ELIGIBILITY

Below is the criteria used to determine a student's eligibility for the Camps, Sports and Excursions Fund (CSEF).

Criteria 1 – Eligibility

To be eligible* for the fund, a parent or legal guardian of a student attending a registered Government or

non-government Victorian primary or secondary school must:

- on the first day of Term one, or;
- on the first day of Term two.
- a) Be an eligible beneficiary within the meaning of the State Concessions Act 2004, that is, be a holder of Veterans Affairs Gold Card or be an eligible Centrelink Health Care Card (HCC) or Pensioner Concession Card (PCC) holder, OR
- b) Be a temporary foster parent, and;
- c) Submit an application to the school by Friday 13th February.

Parents who receive a Carer Allowance on behalf of a child, or any other benefit or allowance not income tested by Centrelink, are not eligible for the CSEF unless they also comply with one of (a) or (b) above.

Criteria 2 - Be of school age and attend school in Victoria

School is compulsory for all Victorian children aged between six and 17 years of age inclusive. For the purposes of CSEF, students may be eligible for assistance if they attend a Victorian registered primary or secondary school. Typically, these students are aged between five and 18 years inclusive. CSEF is not payable to students attending pre-school, kindergarten, home schooled, or TAFE.

Eligibility Date

For concession card holders CSEF eligibility will be subject to the parent/legal guardian's concession card being successfully validated with Centrelink on the first day of either term one (28 January 2020) or term two (14 April 2020).

HOW TO APPLY
Today your child will receive an application form. If you applied for the CSEF at Red Hill Consoli
dated School in 2019, you do not need to complete an application form in 2020 unless there has

been a change in your family circumstances.

You only need to complete an application form if any of the following changes have occurred:

new student enrolments; your child has started or changed schools in 2020 or you did

not apply in 2019. □ **changed family circumstances**; such as a change of custody, change of name, concession card number, or new siblings commencing at the school in 2020.
